### Terms of the Contract

#### Room Charges

There is a \$250.00 room rental charge for private usage of the lounge, exceptions may occur. Any rental after 5 pm Thursday – Saturday requires a minimum spend of \$2,000 (2 Hours minimum time frame). \$1,000 per additional hour (I.e. 3 hrs. = \$3,000 minimum spend). Food and/or alcohol will go toward the minimum spend. The room charge(s) shall be summarized on the Financial Summary herein. Gratuity and tax is NOT included with the room fee.

#### Deposit and Final Payment

A \$500 deposit is required to book the event at the requested date, exceptions may occur. Final payment or the remaining balance will be made the same day as the event. [No split checks are permitted on buffets.] For final payment only, we accept cash and credit cards (Visa, MC, Amex and Discover) on the day of the event.

#### Cancellation and Deposit Forfeiture Policy

The following cancellation and deposit forfeitures apply: Must give 14 full days' notice of cancellation to receive full refund. If less than 14 days' notice is provided, 50% of the estimated total cost of party will be charged to credit card held on file.

### Final Guest Count

A FINAL HEAD COUNT of all adults and children must be provided by 1:00 p.m. SEVEN days prior to your event. This is the number of people you will be charged for in the final bill. If fewer adults attend your party, you will still be charged the fixed price per adult based on the final head count. If additional adults and children attend, there will be a Parkway liaison to assist you to determine if more buffet headcounts are needed at that time or later in the evening to add to your final bill.

### Alcoholic Beverages

No alcoholic beverages may be brought onto the property or taken from the premises with the exception of approved wine with a corkage fee (please inquire within). In the interest of protecting our patrons and the general public, Parkway and its employees have the right to refuse service of alcoholic beverages to any patron or guest who by his or her behavior or appearance is believed to be incapable of tolerating further alcohol consumption.

### Compliance with the Law

This Contract is subject to all applicable federal, state and local laws, including health and safety codes, alcoholic beverage control laws, disability laws and the like. The parties agree to cooperate with each other to ensure compliance with such laws.

### Impossibility

Parkway and its owners shall not be held liable for failure to carry out the function due to fire, flooding, electrical failure, plumbing issues, HVAC system malfunctions, Country Club Plaza and the City of Kansas City, MO malfunctions, an act of God or any other condition beyond reasonable control.

### Indemnification

Customer hereby indemnifies and holds harmless Parkway, its owners, employees, and agents from any and all damages, actions, suits, claims or other costs (including reasonable attorney fees) arising out of or in connection with any damage to the property. Customer shall immediately notify Parkway of any damage or injury of which they have knowledge in, to, or near the property, regardless of cause of such damage or injury.

### Band or DJ Booking (optional)

If the host wants a band or DJ at the event they have two options:

The customer can book and bring in their own DJ or band to perform. The band or DJ can either use all of the audio equipment at Parkway or bring their own and check below and opt out of using the equipment. If the band uses the equipment provided by Parkway the host assumes all liability to damages to equipment and agrees to promptly pay for the equipment to be replaced. If the customer opts out of using Parkway's music equipment, a face to face site meeting will be required 7 days out of the event with a Parkway manager and sound tech to discuss and make sure the band or DJ is executed correctly.

By request from the customer, Parkway will book a band or DJ for the event. There is a \$50 fee associated with this service. This does not include the cost of the band to play your event. If you are interested in this, please list the type of band or DJ below or you can allow Parkway to recommend a band or DJ. By electing this service you also agree to hold Parkway, its owners, employees, and agents harmless for the experience and performance of the band or DJ at the event.

Setup Fee

If a band or DJ is hired for the event and the host has not opted out of using the equipment at Parkway there will be a \$50 setup fee. This fee is waived if the equipment at Parkway is not used, however, a face to face site meeting will be required 7 days out of the event with a Parkway manager and sound tech to discuss and make sure the band or DJ is executed correctly.
